


## Without a Child Advocacy Center... »

An abused child may be **retraumatized** by having to tell their story over and over again in scary places like police stations or hospitals. Children rely on their caregivers to **blindly navigate the entire process alone** - police, doctors, therapists, lawyers - *it's all on them*.

Child abuse knows no boundaries. It affects children from diverse backgrounds of race, religion, and socioeconomic status.

## WITHOUT A CHILD ADVOCACY CENTER (CAC):

The estimated lifetime cost of nonfatal child abuse is more than \$830,928 per case, putting a heavy burden on our social service systems.

A recent national cost-benefit analysis of the CAC model shows that CAC's save approximately \$1,000 per case in services to children and families during the course of an investigation.



Mission Kids has transformed Montgomery County's response to child abuse cases. But we want to do more than just change it. We want to *eliminate it*.
